Communications between Supreme Councils are normally conducted by Grand Secretaries General. Brethren should therefore not attempt, without the Grand Secretary General's prior permission, to make direct contact with another jurisdiction.

The above is extracted from the accounts audited by Haysmacintyre, Chartered Accountants. If any member of the Order wishes to view the audited accounts, they may do so with prior notification to the office.

As last year the surplus mainly represents the amount of the Centenary Appeal Fund spent during the year which has been transferred to the Fixed Assets of The Supreme Council. It does not represent a "cash" surplus.

ANNUAL DUES and FEES

The Supreme Council has decided that the Annual Dues payable on 1^{st} July 2012 will increase to £15.00 (plus VAT where applicable) for every subscribing member of each Chapter during all or part of the preceding year. Districts overseas (except where special arrangements apply) will remit £12.00 per subscribing member, retaining the balance of £3.00 to help defray District costs.

The fee for perfection will increase to £25 (plus V.A.T. where applicable) from 1st July 2012.

DISTRICT LEVIES

The maximum levy that each Inspector General is authorised to make on each subscribing member in his District/ Group to help defray District/Group costs remains at £1.20.

CENTENARY OF 10 DUKE STREET

The Centenary Appeal is now closed and the Supreme Council wishes to thank all those who gave so generously. Further work was carried out in 2011, particularly improving the lighting in the Grand Temple, and the final elements will be completed in 2012 to bring to conclusion a very satisfactory episode in the history of Ten Duke Street.

CONFERENCE FOR INSPECTORS GENERAL

The first conference to be held for Inspectors General took place in June at Duke Street. It was attended by 42 Inspectors General from England and Wales and 4 from Districts Overseas. A considerable number of topics were discussed and several initiatives are being developed, in particular the role of the Almoner and the identification of suitable candidates for the Order. Further details of these initiatives will be circulated in due course.

QUALIFICATION FOR MEMBERSHIP

Brethren are reminded that all candidates for membership of the Ancient and Accepted Rite under our jurisdiction must profess the Trinitarian Christian faith and have been Master Masons *for at least one year* as set out in Rule 36 (a)(ii) of the Rules of the Order. Proposers and seconders must check that their candidates are duly qualified.
